**Stallion Breeding Certificate for the year   2019**

*(Equivalent to "Parts I/II of Mare Breeding Record" described in BBR)*

**Stallion Owner Responsibilities:**

This "breeding certificate" must be prepared by the **stallion owner**, or agent, signed and returned to the FPZV USA Office along with a copy of mare's registration form before October 1 of each year. This should be filed along with the Stallion Breeding Report which is also due by October 1. Copy of this form must be given to mare owner at time of breeding. **Important: If breeding is performed by shipped semen/AI (or ET), copy of this form should be sent to mare owner along with semen so that mare owner can obtain veterinarian's signature for insemination which is REQUIRED.**

**Mare Owner Responsibilities:**

Mare owner must provide a copy of mare's registration certificate to the stallion owner on or before the time of first breeding attempt, whether by live cover or AI/ET. **If Breeding is via AI mare owner agrees to return signed copy of this form (per veterinarian) to the stallion owner within 30 days of last breeding attempt OR prior to October 1, whichever comes first.** Within **28 days** of foaling, the owner of the mare shall forward another copy of the Stallion Breeding Certificate, copy of mare's registration paper, Birth Report/Foal Registration Form and appropriate fee(s) (see current fee schedule) to the FPZV USA Office. **All above requirements must be met or foal may not be eligible for registration.**
